Box 45, Basye, VA 22810 or the Republican Secretary: Ms. Amanda McDonald Wiseley in person or by mail: 183 East King Street, Strasburg, VA 22657, which must be received not later than Monday, March 16, 2009 by 5:00 p.m. Postmarks will not govern. If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared elected, and no canvass will be held for such purpose.
